Public Comments: None.

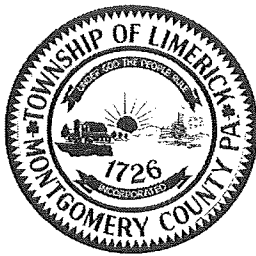
